Rich Koenig receives Fuller Award for 28 years of service

R ich Koenig, water supply specialist, Nebraska Health and Human Services, Department of Regulation and Licensure, was named the George Warren Fuller Awardee at the 2001 Fall Conference for 28 years of outstanding service to the water industry. This is the highest honor given by AWWA, and will be presented to Rich at the National AWWA Conference June 16-20 in New Orleans.

Rich was a member of the Nebraska Section AWWA Board of Directors from 1995-2000, and served as Nebraska Section chair in 1999. He continues to chair the Cross Connection Committee.

His career includes service with a well-drilling company (1973-1980); water operator for the City of Madison (1980-1990), and 11 years with Nebraska Health and Human Services. He works in the northeast field office (Norfolk). Even though his co-workers are very proud of Rich's latest achievement, you won't see his State vehicle equipped with lights and sirens nor will he be wearing a badge, notes his supervisor.

Rich founded the Nebraska Chapter of the American Backflow Protection Association (ABPA), and has served nine years on the Region 12 Board of Directors and six years on the national board. He chairs the Bylaws Committee on the national level. In 1999, he received the ABPA National Gold Eagle Award for his contributions to the organization.

According to the nomination committee, "Rich is one of those rare individuals who will do anything he can for a friend and never expect anything in return. He has earned the respect of water operators and peers throughout the State, not only for his job knowledge and experience, but also for his work ethic, ability to find solutions to problems, and following through with a project.

"His passions include family, church, friends, work and enjoying the great outdoors, and true to his style, he enjoys all of them at the only speed he knows—full speed ahead with throttles wide open."

Rich teaches hunter safety courses for the Nebraska Game and Parks Commission; coaches basketball at a school; serves on the Lutheran School Board and is involved with his church in Madison. He and his wife of 25 years, Diane, have three sons: Brian, David and Chris.

Nebraska Section of the American Water Works! Our Section is embarking on a series of changes that will require the effort and support of all of the members but will reap rich results.

Past Chair **Chip Haas** organized a leadership retreat in January that included the Board, a couple of the committee chairs, and two interested members. **Lori Ropa, Sr.,** AWWA membership marketing manager, moderated the retreat. The purpose of the retreat was to determine where the Section is headed and what we need to do to get there. Several ideas were presented on

The Section will be dusting off the Section's strategic plan and developing a business plan. The Section developed a very good strategic plan in the late 1990s, however work has not continued on the plan.

Our next step will be to hold a strategic planning retreat to update our objectives and focus. Following the updating of the strategic plan will be the development of a business plan. The business plan will define the specific objectives, assign responsibilities, set schedules, and allocate resources. The strategic planning retreat will be held April 9 in Lincoln. **Mark Grace** from National AWWA will moderate the daylong meeting.

The current Board is committed to improve the Section and help the Section grow. We have all heard the same comments and complaints:

- The Section membership is stagnate,
- The membership is graying,
- Minimal involvement from younger members,
- The Section ignores the western part of the State,
- The Section never proposes anything new.

Well, things will be changing and hopefully the value of the membership will out weigh the costs.

In other news, our paid staff office is accepting more responsibility including the set up for the teleconferences and monitoring legislation that impacts the water industry. Their duties include the record keeping, financial management, library management, and setting up the annual conference. The office has a wealth of resources at their

ver the years, AWWA has dealt with many issues regulations, finances, membership, growth, etc. However, never in my nearly two decades with the AWWA do I recall a controversy that has divided the membership as Efficient Utilities.com. This issue dominated the winter meeting of the board of directors. We talked about its impact on sections, potential short-term and long-term revenue losses, potential long-term revenue gains, contracts and legal issues.

After reviewing the contract with the Association's attorney, it was clear there was no alternative, but to continue with the agreement or possibly incur huge financial liabilities.

After a lengthy discussion, the board passed a resolution to support distributor and manufacturer representatives (associate members) by directing the ad hoc committee to consider:

- 1. Discounts to associate member transaction fees for at least one year;
- Discounts to utilities and associate members who work together on the site in a relationship for at least one year, and
- 3. Preference to local regional suppliers and incentives for AWWA memberships.

The board also passed a resolution to:

- 1. Increase customer satisfaction by focusing on customerdriven products and programs, identified by market research throughout the water industry.
- 2. Ensure AWWA's legal commitments are honored and protect the organization from efforts of other parties to undermine commitments of the association.
- Provide a path for reconciliation with members who are impacted, and that also encourages and sustains membership growth.

In other business, the board elected **Marlay Price**, presidentelect, beginning June 2002. Vice presidents for one-years terms include:

Terry Rowlan, North Carolina Dixie Fanning, South Carolina Patricia Lachmaniuk, OWWA, a section of AWWA Andy Richardson, Arizona Chuck Van Der Kolk, Michigan

Curtis Truss, Ohio Section, was named director-at-large.

The board approved the 2002 budget with a projected income of \$28,003,450; projected expenses of

\$27,612,750, resulting in a net income of \$390,700 and capital expenditures of \$495,000.

The board also approved a dues fee increase for active member from \$99 to \$114, effective in 2003. The section book allotment will increase from \$200 to \$400 on an annual basis. And finally, the board approved revisions to the AWWA Strategic Plan.

Thank you for the opportunity to represent you at the winter board meeting. I look forward to representing you at future meetings.

The Second Session of the 97th Nebraska Legislative convened its 60-day session January 2, 2002. LB 926 Adopts the Address Confidentiality Act to provide for confidentiality of addresses of people who may be subject to domestic abuse or stalking. Such people may use the Secretary of State's office as their mailing address.
 Impact: Water systems need to monitor this bills for its effect on their customer service procedures.

Status: Placed on general file February 8 with amendments clarifying abuse, dating relationships, sexual assault.

LB 965 Restricts government collection and use of personally identified information. The bill requires a government entity to post notices if it allows third parties access to personally identifiable information.

Impact: Water systems need to monitor this bill and conform to its requirements with the intent of keeping such information confidential.


Status: Hearing held January 31.

LB 1023 Creates a State Water Policy Task Force to study state law relating to integrated management of hydrologically connected ground and surface water.

Status: Placed on general file February 12 with amendments.

- LB 1140 Changes Environmental Protection Act. Adds language to clarify role of council and composition of members on the council. The bill requires council to consider effect of air, land and water quality standards on children when they adopt regulations.
 Status: Killed February 27.
- LB 1161 Introduced by Senator Carol Hudkins on behalf of Saunders County. Creates a presumption that a water supplier (in this case M.U.D. and the Lincoln Water System) uses all available county services. The bill requires the water supplier to enter into an annual contract with the county to provide the services in exchange for the amount the water supplier would pay if its real property was not exempt from taxation. The bill appeared to be unconstitutional.

Status: Killed January 31.

Nebraska Section/League of Municipalities Seminars: Attendance in 2001 was comparable to previous years. Four seminars focused on disinfection; one on coagulation and filtration, and one on precipitation softening. Attendance was down in cross connection seminars, with 78 participants at five locations.

EPA recently approved the Nebraska Operator Certification Program. Nebraska's share of funds will total \$1.5 million. A large portion of this amount is appropriated; the rest has been authorized. These funds can be used for reimbursement for training and certification of water operators from systems serving 3,300 of less.

The 2002 Nebraska Coalition Water Training Calendar lists all the seminars scheduled this year by the Nebraska Section AWWA, League of Nebraska Municipalities, Nebraska Health & Human Services, Nebraska Rural Water, Midwest Assistance Program and Nebraska Environmental Training Center. Richard (Dick) D. Hawes, 76, died December 11, 2001. He began his water industry career with M.U.D. in 1950 and was

Brief notes

The City of Duncan plans to build a new water treatment plant thanks to a \$250,000 Community Development Block Grant and a \$565,000 state loan.

With the current system, which has no treatment plant, the average Duncan resident currently pays about \$3.40 per month for water. The village board estimates that cost will increase from \$15-\$30 once the new plant goes on-line.

The new \$810,00 plant, north of town, is projected to meet the needs of the community for the next 20 years. The village currently receives its water from three wells. However, nitrate levels are too high to build a new well and the \$1 million cost to connect to the Columbus system exceeded the cost of a new treatment plant.

It's estimated construction of the plant will be completed by December 2002. **Keith Gilmore,** Gilmore Engineering, Columbus, is working with the village on the project.



Gold Water Drop Award

Some of the projects included: Diesel power plants, water and sewer work for small communities, fallout shelters for the U.S. Army Corps of Engineers, an energy plant for St. Elizabeth's Hospital and work for the City of Lincoln.

In addition to his 50-year involvement with AWWA, John also has been active with the American Society of Civil Engineers, American Society of Mechanical Engineers, National Council of Engineering Examiners and Nebraska Examining Board for Engineers and Architects. He is past president of ACEC.

Water Industry Service Awards

During his tenure with the city, Gene oversaw the construction of a 2.5 mgd lime softening water treatment plant and 8.5 miles of water mains. He is responsible for 25.3 miles of mains, 254 valves and 145 hydrants. **Dennis Langdale,** water foreman, Beatrice Board of Public Works, joined the utility in 1973 as a laborer, advancing to foreman in 1990. He hold Grade III water and Grade VI backflow certifications. Dennis oversees a construction department that installs new and replacement water mains.

"Dennis' strongest asset is his ability to get along with employees and the public," said **James Bauer**, manager of the board. "He is a behind-the-scenes person with 28 years of dedicated service."

Water Operator Awards

Alan Slater, water superintendent, City of Fairbury, began his career in 1982 as a water operator, advancing to his current position in 1987. He is a Grade I water operator.

During his tenure with the city, Alan has played a key role in updating infrastructures to maintain compliance with the Safe Drinking Water Act. The highlight of his career has been his role in the building and operation of Nebraska's only ozone plant. He shares his knowledge of the intricate operations with his staff. He actively promoted the filter-to-waste piping project, works to increase the chlorine residual leaving the plant, and produces a finished water with manganese concentrations less than the secondary standard along with a turbidity of less than 0.1 NTU.

Opflow Gimmicks and Gadgets

Frank Newell, control and instrument technician, City of Lincoln, won first place in the 2001 Opflow Gimmicks and Gadgets Contest for his entry, the Aspirator System for Ozone Sampling. The aspirator system eliminates heat, noise, maintenance and repair issues associated with electric vacuum pumps, and provides redundant operations of reliability.

There were 25 entries in the contest, and the top three inventors were published in the August 2001 issue of AWWA Opflow. Frank also received \$300.

At the time of submission, Frank worked for the Lincoln Water System. He has since transferred to the solid waste and wastewater department.

Results to be available in Fall 2003 Section gives \$20,000 for research

Drinking water research projects last year included virus testing in Nebraska water wells, understanding factors controlling copper corrosion and research related to GAX use in removing DBP precursors.

The Section authorized \$20,000 for research to be conducted by the UNL Civil Engineering Department on the assessment of source variation in copper concentrations in Nebraska drinking water systems. Total cost for the research is estimated at \$54,747. Funding also will be provided by UNL, Nebraska Health and Human Services, the U.S. Geological Survey and City of Waverly.

The goal of the research is to more fully understand the causes of variation in copper concentrations from Nebraska water suppliers that occasionally violate the copper standard for safe drinking water. Specific objectives:

- 1. Better understand the water chemistry and scale composition in Nebraska water systems by obtaining water and copper pipe samples.
- 2. Obtain frequent copper dissolution data from three communities that are borderline copper standard violators to identify factors that lead to variations in the copper concentrations. Of interest are factors beyond sample protocol errors and improper sampling points.

Research will consist of field and laboratory analyses. To meet the first objective, six-inch samples of copper pipe and water samples will be collected from 18 communities (*typically a municipal building*).

- Four communities with consistent past violations of the copper standard.
- Four with consistent very low copper concentrations.
- Ten with a wide variation in copper concentrations, such that these communities violated the action level once or twice during the past decade.

The drinking water system operators in communities with wide variation in copper concentrations will be asked to complete a survey concerning the conditions of each sampling point and the water system history of the community. Data will be analyzed to identify possible explanations for the variation in copper concentrations.

Researchers will evaluate obvious factors (*water softeners, sample protocol errors*) and subtle factors (*proximity of copper pipes to heating ducts that could affect water temperature during stagnation*).

Water Utility Council by Jerry Obrist

The Second Session of the 97th Nebraska Legislative adjourned its 60-day session April 19, 2002. We monitored five proposals last session. All were killed except one which was amended into another bill during the last week of the session. It was signed by the Governor.

The new law, LB 1003, effective July 20, charges a Governor-appointed Water Policy Task Force to examine statutes governing the management and use of our state's surface and ground waters. Issues to be examined include:

- Review of Nebraska's conjunctive use management issues.
- An evaluation of the utility of allowing temporary water transfers, and if needed, draft a proposal and procedures to authorize and implement a temporary water transfer law.
- An evaluation of the utility of authorizing additional types of permanent water transfers, and if needed, draft a proposal and procedures to authorize and implement additional types of permanent water transfers.
- A determination as to the usefulness of water leasing or transfers, and development of a potential water banking system to facilitate temporary or permanent transfer of water uses.
- A determination as to what other ways, if any, inequities between surface water users and ground water users need to be addressed and potential actions the State could take to address any such inequities.

According to Senator Ed Schrock's office (Elm Creek), chair of the Natural Resources Committee, a meeting facilitator (consultant) will be hired by the State. After the consultant is on board, members of the task force will be appointed by the Governor, as per the statute. The task force will consist of the following:

- 20 irrigators, with at least one irrigator from each of the State's 13 river basins, giving consideration to maintaining a balance between surface and ground water users.
- Three representatives from differing agricultural organizations.
- Two representatives from differing recreational organizations.
- Three representatives to represent the State at-large.

- Five representatives suggested for the Governor's consideration by the Nebraska Association of Resources Districts.
- Four representatives suggested for the Governor's consideration by the Nebraska Power Association.
- Five representatives suggested for the Governor's consideration by the League of Nebraska Municipalities, with consideration given to maintaining a balance between larger and smaller municipalities.
- And, such other members as the Governor deems appropriate to provide the task force with adequate and balanced representation.
- Additional members of the task force will include a representative of the Department of Natural Resources, Attorney General's office and the chair and vice-chair of the Legislature's Natural Resources Committee.

After an executive committee of the task force is established, the group will apply for a \$350,000 grant from the Nebraska Environmental Trust Fund (deadline is September 9, 2002). Additional funds may come from gifts, grants, donations, transfers according to statutes or money appropriated by the Legislature. The group has 18 months to complete its work once the Governor notifies the Legislature that all members of the task force have been selected and a facilitator (consultant) is selected.

Section gives \$20,000 for copper corrosion research at UNL

To meet the second objective, a pilot-apparatus will be installed in three communities for four months (*June-September*). If possible, Hallam, NE will be one of the communities with a pilot apparatus. The other two communities will be borderline copper violators located near Lincoln.

The pilot apparatus will be similar to that used by Schuerman et al. (2000). It will contain at least four 2-foot sections of aged copper pipe removed from the same building that contains the apparatus.

Water from the community's distribution system will be allowed to flow through the pipes at a set flow rate on a set timer schedule, allowing for a 12-hour stagnation period before sampling.

The four different pipes will represent different temperature scenarios (*no chemical treatment will be used*). Influent and post-stagnation water samples will be collected at least three times a week from the apparatus.

Also, at least once during the dry period of summer, the water from each of the communities' wells will be frequently sampled during a period of intensive pumping to identify if subtle changes in dissolved gases (*oxygen and carbon dioxide*) occur, temporarily creating a more corrosive environment in the pipes.

The copper pipe samples collected in the study will be examined to learn more about the scale layers.

- The scale will be viewed under a scanning electron microscope.
- An elemental analysis of scale layer will be performed using x-ray spectroscopy.
- A microbial analysis will for types of microbes on the surface of pipes will be performed.

For both objectives, water samples will be analyzed for relevant water chemistry parameters (*i.e.*, *dissolved and particulate copper*, *pH*, *alkalinity*, *carbon dioxide*, *dissolved oxygen*, *dissolved organic matter*, *common anions and hardness*). The influent samples also will be closely monitored.

This summer UNL Civil Engineering Graduate Student **Junling Qiu** began working on the project. It should be completed in about 18 months. The work will be presented at the Section's annual conference in Kearney in Fall 2003.

AWWA to develop accreditation program for water suppliers

WWA is developing an accreditation program that will be voluntary for all utilities, regardless of size. Parts of the program will be available in 2003. The program is a form of a verification of the application of standards of best practice to deliver high quality services and not an attempt to by-pass the regulatory compliance (it is "above & beyond").

The program should result in less reporting requirements and less regulatory oversight, and an improvement of customer satisfaction with water suppliers.

The program will provide a tool for primacy agencies to evaluate utilities with the real need for oversight and assistance.

It also will result in a change of attitude from seeking compliance with existing regulations to seeking the best strategies to best protect the public health.

Accreditation has been named a high priority effort of the AWWA. The Accreditation Policy Committee provides links to the Councils and Committees of AWWA, as well as the Government Affairs office of AWWA.

The Accreditation Program is set up independently of the existing quality improvement programs such as QualServe or Partnership for Safe Water. The existing utility quality improvement programs may be used by utilities to prepare for the accreditation as they contain the necessary tools, however these programs are not required for accreditation.

Program components to be developed through individual efforts but will start at the same time:

- 1. **Policy and Procedures:** Developed in June 2001 by a consultant to AWWA, experienced in accreditation in other branches of industry.
- 2. **Standards:** To be developed by groups of AWWA volunteers, experts in respective fields, and edited by a Standards committee.

The first components to be developed are: distribution system operation and management (developed and available for comments), source water manage-

ment and protection (under development), and water treatment plant operation and management.

After piloting the implementation of these standards at both large and small systems in 2003-2005, other areas of accreditation will be developed and will include: conservation, customer relations, business, financing, and planning, as well as wastewater treatment, wastewater collection, biosolids handling and management, water reclamation.

- 3. **Benefits and Incentives:** Under development by consultants to AWWA:
 - a. Financial incentives (lower interest rates on bonds/grants, lower insurance rates)
 - b. Regulatory (less oversight from primacy agencies)
 - c. Social (public confidence, recognition, and credibility)

Once the accreditation program components are proposed in a draft form and representatives of regulatory agencies and professional organizations are briefed about the process, a stakeholder process, facilitated by a professional firm, will be initiated.

The stakeholders will provide feedback, express concerns, indicate individual issues, and participate in building the program.

The Grade 1 Water Operator Course has been rescheduled for August 5-9 in Hastings at the Hastings Utilities Facilities.

A Grade 1 test will be given at the end of the course August 9.

Minimum requirements for a Grade 1 Certificate are:

- 1. Prior successful completion of Grade 2 Certification exam, and
- 2. With a BS degree including course work in sanitary sciences:
 - a. Three years in responsible charge or operation of a PWS, or
 - b. Three years as a PWS regulatory agent or provider of technical assistance to PWS(s), or
- 3. With four years of college:
 - a. Four years in responsible charge or four years as a certified water operator of a PWS, or
 - b. Four years as a PWS regulatory agent or provider of technical assistance to PWS(s), or
- 4. With a high school diploma or equivalent
 - a. Six years responsible charge of a Class 2 or 3 PWS, or
 - b. Eight years as a certified water of a PWS, or

c. Eight years operation of a PWS under the supervision of a Grade 1 Water Operator

d. Eight years as a PWS regulatory agent or provider of technical assistance to PWS(s).

Planning for drought conditions is the key

Currently, many parts of the state are in drought conditions. Some water systems have imposed water use restrictions. Of these, some have a history of imposing restrictions every summer when consumer demands exceed the capacity of the water supply system. Whatever the case, important questions to consider when imposing water restrictions are:

- What will trigger the declaration to impose water restrictions?
- What types of use and class of water user (residential, commercial, etc.) will be restricted?
- What specific goals in water use reduction are to be achieved by issuance of restrictions?
- What penalties will be imposed on a consumer if restrictions are not followed?

• Will fire protection capabilities be met with the restrictions imposed?

This is the third year the Nebraska Department of Health and Human Services Regulation and Licensure has assisted water systems impacted by drought conditions. We've also helped systems making preparations for that possibility.

One relatively common discovery is that many water systems have authority, by ordinance, to restrict water usage within the system.

Many of those ordinances are written in general terms and provide few, if any, of the above mentioned specifics. The ordinance can be further specified to cover those necessary specifics, or perhaps a standard operating procedure or water conservation plan can be adopted in-lieu-of ordinance work. Consult your attorney to determine which process is best applicable to your situation.

Triggers are used as an indication the water system is not meeting the demands placed upon it <u>and</u> continuation of those demands will place the system in a low or no pressure situation.

Triggers could be tank levels, static/pumping levels in wells, gallons per capita per day usage, system pressure, etc.

Every system is different, so triggers have to be chosen based upon system and operational characteristics. Good background records of well performance and distribution system conditions are of utmost importance in this regard.

Water levels in storage tank must be maintained for fire protection in many water systems. When imposing restrictions, assure the appropriate storage level for fire protection will be maintained. Mutual aid agreements with neighboring communities for fire protection can be a necessity during times of water restrictions.

If a current restriction is not accomplishing your goal of water use reduction and storage tank water level, have in place an additional restriction step for implementation.

The key is preparation. Some problems observed this summer occurred literally overnight. A written water restriction plan in place will save a great deal of time, and avoid confusion if there comes a time when water use restrictions have to be implemented.

Reimbursement funds for training in Nebraska only Water operator reimbursement grant

Nebraska Health and Human Services Department of Regulation and Licensure is authorized to begin drawing on the funds for the water operator reimbursement grant funded through the U.S. Environmental Protection Agency (EPA). These funds are available to eligible water systems and operators of those systems for reimbursement of costs associated with water operator training. Eligible water systems are those community (CWS) and non-transient non-community (NTNC) public water systems serving 3,300 or fewer people.

Chair's comments

arning: The Nebraska Section AWWA is changing and we're taking you with us. A threat? No. A kidnapping situation? Maybe. As discussed in the previous issues, the

Board has decided to move the Section forward to actively address the issues confronting our industry rather than sit on the side lines. They are to be commended for this approach.

The water industry is facing challenges today that cannot be ignored. Some of the challenges are the same ones we've repeatedly faced including new regulations, additional monitoring requirements and public information. Some of the newer challenges include severe budget deficits, drought, lack of qualified personnel to fill positions and terrorism.

Make no mistake, the Section leadership has always made every effort to be a leader in the water industry. Our committees and the Board have done an outstanding job of confronting the issues as they have arisen. But now we must do more.

The work of the Section has been carried for too long by a small number of dedicated individuals. If you review the committee chair assignments, the same people continue to hold the same positions and perform their work with little or no assistance. That is about to change.

The Strategic Plan for the Section will be finalized this Fall. The Plan contains several new initiatives to benefit everyone in the industry. For example: Most people know very little about the water industry much less opportunities for employment in the industry. At the same time, several of our operators and engineers are nearing retirement age while the pool of available workers continues to shrink. One initiative is to contact trade schools and colleges to work with them on making their students aware of the water industry. We also will also work to have speakers or booths at their career fairs. The purpose is to make people aware of what our industry does and how they can be a part of it.

Another initiative is a closer working relationship with our lawmakers, on the State and National level. We cannot lobby. However, we can spend time informing our representatives about our needs and providing background about the issues so they can make intelligent votes. One issue currently playing out is the allocation and management of our surface and groundwater. We need to be actively involved in the discussions to protect our interests. If not, we may find our options limited when we need to expand or develop new well fields.

Another issue is funding for improvements. Not just the improvements needed to meet the upcoming regulations but replacement of aging equipment and facilities. Again, we need to make legislators aware of our industry and what are needs are.

Recruitment for committees will be heavy this Fall. It would be nice if all of our members decided on a committee and gave the chair a call. The chairs and the Board will be making calls asking you to become involved. Expertise is not required. A large time commitment is not required. A large bankroll is not required. Like parenting, the biggest impact you can make is just showing up.

Spend a couple hours a month giving back to the Section that is working hard for your industry. If you want to know more about the committees, give the chairs or me a call. The Section will continue to move forward but we will get there faster if everyone helps.

Farewell. This is my last article as Chair. I do want to thank everyone for allowing me to serve on the Board for the past several years. I have learned a tremendous amount about the industry and

Water policy task force named

overnor Mike Johanns and Senator Ed Schrock of Elm Creek, chairman of the Unicameral's natural resources committee, recently appointed 49 people to the Water Policy Task Force.

The task force, authorized by the Legislature earlier this year, will address several key issues relating to the laws governing the management and use of Nebraska surface and ground water.

The governor said input from individuals and organizations not appointed to the task force will be important as the group reviews and makes recommendations on some of the most important issues facing Nebraska.

Specifically, the task force is to determine if any changes are needed to adequately address Nebraska's conjunctive usemanagement issues. The task force also will:

- Evaluate authorizing temporary water transfers and or additional types of permanent water transfers.
- Examine the potential and need for a "water banking system" that would facilitate the temporary or permanent transfer of water uses.
- Determine if there are inequities between surface water users and ground water users that need to be addressed and, if

necessary, to develop potential actions to address these inequities.

• Draft legislation and procedures for authorizing and implementing changes in laws, if they are considered to be useful. The task force will meet at least four times a year. It also will select an executive committee of three irrigators, and one representative each from agriculture, environmental, recreational, power and municipalities interests.


Also on the executive committee will be one member from the state at large and the director of the Department of Natural Resources, a representative from the Attorney General's office and the chair and vice-chair of the Legislature's natural resources committee.

The executive committee will develop and make recommendations for consideration by the entire task force.

The task force will then forward its recommendations to the Legislature and governor by December 2003. Members of the task force are:

Water operator reimbursement grant

Reimbursement Filing Guidance

To ensure PWS Systems and/or operators receive reimbursement in a timely fashion, the following filing guidelines are recommended by the Department:

For eligible training activities that occurred since July 15, 2002, the water system or operator should submit the application for reimbursement within 45 days after the conclusion of the training event.

Eligible training/reimbursement activities

A. Operator Certification Training Courses for Grades II, III and IV (includes Correspondence Course)

- 1. Registration fee and text books
- 2. Certification fee
- 3. Reasonable mileage to and from course location at \$0.365 per mile. Reasonable mileage is defined as the most direct route to and from a training event. This means usually map mileage and reasonable allowance for local travel depending on circumstances.
- 4. This reimbursement is limited to **one** course and exam and if needed **one** re-take of the exam per calendar year.

B. Individual Examinations for Grades II, III and IV Water Operator Certification

- 1. Exam and Certification fee
- 2. Reasonable mileage to and from nearest Field Office to test at \$0.365 per mile.
- 3. This reimbursement is limited to **one** examination and if needed **one** exam re-take per calendar year. <u>This does not allow for two additional exam re-takes if</u> <u>an individual is not successful in testing under Section</u> <u>A above</u>. This is intended for reimbursement to Operators up-grading their licenses independent of the training courses.

C. Conferences/Seminars/Workshops for Certification Renewal Purposes

This reimbursement covers registration fees and reasonable mileage to and from the training events at \$0.365 per mile as long as the following conditions are met:

- 1. Eligible conferences, workshops or seminars have been approved by the Department for continuing education applicable to Water Operator Grades I - IV and are conducted within the State of Nebraska.
- 2. Eligible applicants will only be reimbursed for training to meet the requirement for 15 hours of training every three years.

D. Volunteer Operators

Volunteer operators are defined as operators of eligible CWS or NTNC public water systems that receive NO compensation in any form or manner for their services to the system as a certified water operator.
