## Public Hearing at 1:30 p.m. CT

The DHHS Division of Public Health is holding this hearing to accept comments on proposed changes to regulations for **Public Water Systems** in Title 179 Chapters 2-002, 3-5, 12-14, and 16 of the NAC. A new chapter, 179 NAC 8, Ground Water Rule, is also proposed.

The proposed changes will update the regulations to bring them into compliance with the Nebraska Safe Drinking Water Act and the U.S. Environmental Protection Agency regulations. The changes add requirements for ground water systems that detect total coliform in distribution samples, revise requirements relating to lead and copper, revise disinfection byproduct requirements, update Code of Federal Regulations attachments and analytical methods, and update reporting requirements.

Authority for these regulations is found in Neb. Rev. Stat. Sections 71-5301 to 71-5313 (the Nebraska Safe Drinking Water Act) and 81-3117(7).
