NWEA sessions will begin on Thursday the 4<sup>th</sup> and conclude at noon on Friday the 5<sup>th</sup>.

Wednesday and Thursday there will be showcase opportunities from 10:00–10:30 a.m. during break and several events scheduled in the exhibit hall to promote traffic 1:30–7:00 p.m. As always, the Social Hour is taking place both evenings in the exhibit hall at approximately 6:00 p.m. Other activities include Top Ops and Water Tasting competitions.
