Director's Report: Philanthropy and Education in the Water Sector

It is an honor to be selected by the Nebraska Section to serve as your Director for the next three years. I started my term at the end of the Annual Conference and Exposition (ACE) in Chicago in June. I want to thank the outgoing Director, John Olsson, for his advice and guidance as I have transitioned into this position. John has provided strong leadership during the past three years. I am especially impressed by his efforts to engage the Nebraska drinking water industry in being a proactive leader in the state to find Total Water Solutions, through the ad hoc committee by that name. I know that John will continue to provide leadership for the section into the future.

The Nebraska Section served as the host to an AWWA Regional Section Officers Meeting (RMSO) on May 13 and 14 in Omaha. We had twenty-five participants, with six of the nine sections in our region represented. I want to recognize Ben Day, Mary Poe, Jim Shields, and Tony Bilek for their hard work in finalizing the preparations to host the RMSO. Our colleagues from Wyoming commented upon the warm Omaha weather, while those from Texas bemoaned the cold. We had highs in the 70s and a low of 38°F.

At the RMSO, a range of topics were discussed including topics such as Membership Model Changes, AWWA's Philanthropic Initiative (more on this below), and Community Engineering Corps. The most valuable aspect of the meeting was the conversations and sharing of ideas between sections.

The Nebraska Section AWWA has long been aware of the tremendous importance of operators to the success of the water industry, and the need to continue to recruit and train operational staff. In 2009, Mike Wentink provided leadership for a joint Nebraska Section AWWA and Nebraska Water Environment Association survey which found that the median age of operators in Nebraska was over 51 years old, and 45% planned to retire within 10 years.

AWWA has started a new philanthropic initiative called the Water Equation to address the critical shortage of skilled water professionals. Plants need skilled workers to operate increasingly complex controls of water and wastewater systems. Nationally, the water industry faces a critical shortage of operators, and the need is expected to increase by 6% in the next decade.

Thus, to help attract talented new people and to retain and enhance the skills of our current membership, AWWA wants to double the number of scholarships awarded annually. These scholarships will be for all levels, bachelors and graduate degrees and

continuing education for operators. AWWA national is providing matching funds to Sections that create new scholarships, like the Nebraska Section has recently done. Scholarships for degree-students normally can only be spent on an accredited degree program.

With the One AWWA Operator Scholarship, there is more flexibility as to how it is used. These funds could be used for certification/licensure, two-year community college water programs, professional training programs, books and manuals, and even to send a Section's meritorious service award winner to ACE. Please watch for more announcements related to the Water Equation and the associated scholarships.

In closing, I am looking forward to representing the Nebraska Section as your Director for the next three years. As always, I encourage you to get involved with the Association in some manner. Your feedback and involvement are critical to the success of our Association. This is an exciting time to become involved in AWWA and the organization has with abundant resources available to help you with your job.

Washington Fly-In Recap: Talking About WIFIA, SRF Funding, and Lead

The Nebraska Section AWWA is cooperating with the AWWA Water Equation Campaign to award two scholarships for \$1,000 each to water operators for training and education. The "One AWWA" operator scholarship can be used for certification or licensure, a two-year water related associate's degree, or other forms of training. The scholarship also comes with a one-year operator membership in AWWA.

Applicants must be current water operators or those seeking to enter the profession, and must be pursuing a license, certification, or degree related to the water industry in Nebraska.

The scholarships will be awarded at the Fall Conference, and the Nebraska Section AWWA will require a follow-up report from the recipients about their pursuits for reporting at the following year's conference. On April 13th and 14th more than 130 AWWA members from 47 states blanketed Capitol Hill with the association's message that the nation must invest more in water infrastructure during the 15th annual AWWA Water Matters! Fly-In. Nebraska was represented by Milo Rust from Chadron, Chad Roberts from Norfolk, and me. We had meetings with all five congressional offices and we focused on infrastructure needs and the lead problem. We distributed two position papers at each meeting: One on lead and the other on funding for water infrastructure.

Our meetings went well and we were received positively by all of the offices. All of the offices seemed to be supportive of continuing to fund the SRF program and recognized the program's importance to Nebraska. Senator Fischer's office seemed especially well-versed about the Water Infrastructure Finance

and Innovation Act (WIFIA) and they are hoping to find uses for the money in Nebraska. Another highlight from the visit to Capitol Hill was that Congressman Adrian Smith attended our entire meeting at his office.

Help Us to Help You Get Eligible for Security Grants

Pre-Conference Workshop Registration

Operators from several water systems have asked recently about whether water system security grants are available, and what to do to get them. The short answer starts with "Yes, but..."

In the early 2000s, DHHS started the security grant program using funds from the Drinking Water State Revolving Loan Fund (SRF). We looked at the description of uses in Federal guidance that the funds could be used for, and received approval from US EPA Region 7 for the program.

We first had to develop a set of rules to implement the program. At first, they were pretty simple, but over the years they have grown more complicated. However, one requirement has been a constant for the life of the program: At least one licensed water operator for a system had to have successfully passed the Incident Command System/National Incident Management System training, or ICS/NIMS.

At first, it was just two modules: ICS-100 and ICS-200. Later, we added ICS-700. The requirement for ICS/NIMS 100, 200, and 700 training still exists today in order for a public water system to qualify to get one of our security grants.

More than a few systems are running into the obstacle that a lot of licensed water operators have retired or will retire soon. Many systems took it for granted that they had at least one licensed operator with ICS/NIMS training and didn't worry about getting anyone else trained. As the ranks of ICS/NIMS trained staff have thinned out, systems are finding themselves ineligible for grants.

Let your DHHS field representative know if you need to have someone go through the ICS/NIMS training. I am trying to schedule this training in Western Nebraska through NEMA Region 23. Other field representatives can help do the same thing, but we need to be able to show sufficient interest.

Another viable option systems have is to complete the training online. In my opinion, the online training is not ideal, but it is an option if you are disciplined enough to dedicate yourself to it – but take note: the online training is a timed event, so you must complete it in the allotted time or be forced to start over.

DHHS wants to help your water system achieve maximum eligibility for water-security grants, and we would like to help you achieve the required certifications. Please get in touch with your field representatives if you need ICS/NIMS training to get moving in the right direction.

Utilities Helping Utilities Through WARN, the Water/Wastewater Agency Response Network

NEWARN began with a steering committee formed back in 2007 and has since grown to 177 members. When board members give presentations about NEWARN, the audience usually includes many folks who are not familiar with NEWARN. The current NEWARN board is working hard to change that and get the word out.

What is NEWARN?

NEWARN is a statewide Water/Wastewater Agency Response Network (WARN) of utilities helping utilities. The network supports communication and cooperation among member utilities that provides many benefits including:

- Preparation for natural or humancaused emergencies
- Establishment of mutual assistance agreements and processes for sharing emergency resources among members statewide
- A forum for developing and maintaining emergency contacts and relationships
- The resources to respond and recover more quickly from a disaster
- Training to assist utilities to be better prepared for disaster response and recovery

Why do we need NEWARN?

Water and wastewater systems provide our communities with life-sustaining resources that are vital for maintaining public health, sanitation and safety. A community's well-being quickly deteriorates when water and/or wastewater service is interrupted for extended periods of time. And without an adequate water supply, our communities are vulnerable to devastating fires. NEWARN supports efficient restoration of water and wastewater

service, which provides hope to communities for quick recovery from those disasters.

Why should you join NEWARN?

Who is likely to have a specialized pump or valve your system needs to get back on line in a hurry? Another water or wastewater system! So join your colleagues in NEWARN and become part of the network dedicated to keeping our communities healthy, sanitary and

safe.

Our mission is to support and promote statewide emergency preparedness, disaster response, and mutual assistance to water and wastewater utilities. The NEWARN website does this by providing members with emergency planning, response, and recovery information before, during, and after an emergency.

The core of the NEWARN website is the emergency equipment database that matches utility resources to a member's needs during an emergency. Members may locate emergency equipment (like pumps, generators, chlorinators, and evacuators) and trained personnel (like treatment plant operators, field crews, and other staff) that they may need in an emergency.

Nebraska Top Ops at ACE in Chicago: A Top-1/3 Finish

Top Ops participants from the Nebraska Section AWWA competed in Chicago at the AWWA Annual Conference and Exhibition (ACE) in June.

The Nebraska Section Top Ops team, represented by Steve Kelley (Beatrice Board of Public Works), Ken Swanson (Auburn Board of Public Works), and Eric Lee (Lincoln Water System), finished in 6th place out of 19 teams that competed.

The top four finishers in the competition were:

1st - Palm Coast Water Buoys of Palm Coast, Florida Section 2nd - Fort Worth Panthers, Texas Section 3rd - Birmingham Prime Movers, Alabama/Mississippi Section 4th - Aquitards, Illinois Section

Although the Nebraska Section team got off to a slow start during their first of three preliminary rounds, during the second round of preliminary competition the answers to questions posed seem to come their way. During the third round however, answers to the questions became a bit more elusive to the competitors from Nebraska. Only the top four teams in the preliminary competitions advance to the semi-finals.

As currently formatted for the ACE Top Ops competition, this "Quiz Bowl" style of game allows more participation from all the competing teams without the additional burden

Two or three teams compete with questions generated for each round that are randomly selected from a secured question bank. Each competing team is provided with an erasable white board. On one side of the board are the words "No Response". Once the question is shown on the screen, the competing teams have 25 seconds for which to determine the answer and write it on the white board. At the 25-second mark the competing teams show their answers. If a team has no answer, the "No Response" side of the board is displayed.

Correct answers are awarded 2 points, math questions are awarded 3 points, and a "No Response" answer is worth 0 points. If a team answers incorrectly, 1 point is deducted from their score. At conclusion of the round competition points are awarded based on how a team placed in the round (3, 2, or 1 point). Each team competes in three preliminary rounds. The four teams with the highest numbers of

competition points, advance to the semi-final rounds. As teams advance into the semi-final and championship rounds the question content becomes more difficult.

Success in the sport at that level necessitates having a team members with well-rounded knowledge of treatment, distribution systems, regulatory issues, natural sciences, and more. The Nebraska Top Ops team had that knowledge, but even so, some luck is involved with the random selection of questions for each round.

The Nebraska Top Ops team finished in the top third of the competing teams, and missed the semi-final eligibility by only a couple of slots. That is a respectable finish. Congratulations to our competitors for representing Nebraska well!
